NARRATIVE

I am an independent researcher whose work considers metaphysical, clinical and ethical issues that arise around the mind-body line in medicine. Following my PhD, I was academically inactive for fifteen years. During that period I struggled with serious illness, as I pursued the reading and writing that formed the foundation for my current work.

In 2016, I was able to return to academic life as Visiting Researcher at Kennedy Institute of Ethics, then Visiting Faculty at Rotman Institute of Philosophy and, recently, Visiting Fellow at Pittsburgh's Center for Philosophy of Science. My first publication after returning was a 2018 target article published with twelve commentaries. Since that time I've published nine more articles in top journals and collections, delivering twenty presentations to philosophers, clinicians, patients, bioethicists and the general public. I am intermittently disabled by chronic disease, and this is no longer a reality I hide in academic settings. I am committed to raising awareness about research by academics who are disabled, particularly women whose disabilities are invisible. Independent research is often high quality, impactful research.
